

**2017 RUNNING2RESCUE**  
**RELEASE WAIVER OF LIABILITY AND ASSUMPTION OF RISK**

1. I hereby acknowledge that my participation in the Activities is entirely voluntary, and therefore, Trinity Church, Inc. (TC) is not responsible for my participation in the Running2Rescue Event.
2. In cases of emergency, I consent to the examination or treatment of myself by a physician duly licensed to practice medicine in the State of Texas or any health care professional duly licensed to provide health care services in the State of Texas for medical care and services deemed necessary by the medical provider and TC, its agents, servants, and employees. In the event that it is not possible to acquire the services of a physician or health care provider to diagnose and treat Participant based upon the existing circumstances, I also consent to the employees, volunteers and agents of TC to use their best judgment, as "Good Samaritans," to provide medical assistance until a physician or health care provider can be obtained.
3. I give permission to the Doctor or health care professional to provide any and all medical care they deem, in their professional opinion, to be necessary.
4. I agree to pay for any and all medical expenses incurred as a result of the use of this consent.
5. I also agree to fully release and hold harmless TC, its pastors, employees, agents, borrowed servants, contractors and other workers, paid or volunteer, or their heirs and assigns, from any and all injuries, claims, liabilities or causes of action which may arise from my participation in the Activities.
6. I personally assume all risk in connection with said Activities for any harm, injury, or damages that may befall me as a result of my participation in the Activities, whether foreseen or unforeseen, and I still wish to participate in the Activities.
7. In consideration of being allowed to participate in these activities and to use TC's equipment, I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless TC from any and all claims, demands, or causes of action, which are in any way connected with my participation in these activities or use of TC's equipment, whether owned or offered for use by various church members and/or volunteers.
8. I understand that it is my obligation to inform the management of TC of any and all health considerations or medical conditions that would restrict my participation in any and all Activities.
9. I acknowledge that I am not aware of any condition or limitation that would prevent my participation in the Activities. I will not allow myself to participate in the Activities should I become aware of any such condition or limitation and will not allow myself to participate in the Activities should I have any illness or disease which I reasonably understand to be contagious to others or would put others in jeopardy of contracting such illness or disease.
10. I understand that I am fully responsible for any children, registered or not registered, who are in my care at the Running2Rescue event.
11. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in these Activities, I may be found by a court of law to have waived my right to maintain a lawsuit against TC on the basis of any claim from which I have released them herein.
12. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
13. This Agreement represents the entire understanding of the parties and may not be amended unless mutually agreed to by both parties in writing.
14. I have fully informed myself of the contents of this WAIVER OF LIABILITY AND ASSUMPTION OF RISK by reading it before I signed it.

**Read this paragraph if participant is 18 years of age or older:**
